- A. Discussion of the Plan of Conservation and Development Update, Section 2.A., Sustainability Ann Zitkus provided an update. This was circulated and Tom Loto and Ann Zitkus made comments. Ann recommended that everyone on the Commission ask "what does it mean to be sustainable?" and provide feedback.
- B. Annual Report Jim Cordier distributed this, and after evaluation by the Commission he was forwarding it on to the town manager's office.
- C. Jumping Worm Update Tom Loto said he has been dealing with them in his yard. He said sprinkling ground mustard (already crushed) mixed with water agitates the soil and brings them to the surface, where they can then be grabbed and placed in soapy water. He said the band around their bodies is noticeable compared to regular earth worms. He said that the prevention onus is going to have to primarily lie on the distributors of soil, mulch, and wood chips. Ann Zitkus said she is surprised that the word hasn't gotten out more. She wondered if mixing the mulch (used as a part of a solution for de-icing the roads) with the salt would kill the cocoons, or if spreading the mulch would contribute to the spread of the jumping worms. The Commission members wondered if there is a good way to test for the worms in the soils and other gardening materials. Ann wondered about getting an expert opinion on the topic.
- D. CT RC&D ERT Update Jim Cordier was in touch with Jeanne Davies and she has been tied up with another project recently.
- E. CACIWC Conference Reminder, October 29th Was sent in the meeting packet with the PDF materials. Jim Cordier said it will be re-sent with the live links.

She mentioned grants that are available for farmers, in particular, as something to possibly write about.

New State Grant Opportunity for Climate Smart Agriculture

The State of Connecticut will soon be awarding grants for Climate Smart Agriculture and Forestry practices. This is because forests and vegetation are our allies in fighting climate disruption. They take in enormous amounts of carbon dioxide from the air (reducing the greenhouse effect of this gas) and store carbon, much of it in the soil. They simultaneously provide ecosystem services of making clean air, water filtration and storage, and supporting all manner of life. As carbon increases in soil, soil also becomes more productive/life supportive.

"The goal of the grant program is to provide funds to entities throughout Connecticut to support farmers and producers who are implementing Climate Smart Agricultural Practices (CSAP) as identified by USDA Natural Resource Conservation Service (NRCS)" (from https://portal.ct.gov/DOAG/ADaRC/ADaRC/Grants/Climate-Smart-Agriculture-and-Forestry-Grant where more info is available.)

Some of the many examples of Climate Smart Agricultural Practices noted on NRCS website (all the below increase carbon in soil):

- Silvopasture establishment and management of desired tree and forage species on the same land. This may provide forage, shade or shelter for livestock, reduce soil and wind erosion, improve water quality, increase wildlife and pollinator habitat and build soil health.
- Multi-Story Cropping managing an overstory of trees/shrubs with understory
 plants that are separately managed for a variety of products. This may improve
 biodiversity and build soil health. [Managing a Food Forest is related to this, in
 which there are different layers of plants, starting from the canopy layer of tall
 trees, dwarf trees, bushes and shrubs, herbs, vines, and root crops.]
- Alley Cropping planting trees or shrubs in sets of rows with crops or forages
 produced between the woody plants. This may improve crop or forage quality,
 reduce wind and water erosion, improve water quality and build soil health.
- A Riparian Forest Buffer is an area covered by trees or shrubs that is located near, and generally uphill from, a body of water. Implementing a riparian forest buffers may improve water quality, restore diversity of riparian plant communities, provide wildlife habitat and improve stream conditions for certain species.

Farmers and to-be farmers are encouraged to think big. There are **three grant allocation categories:**

- 1. \$1,000,000 to \$1.5 million; Project duration: 3-5 years
- 2. \$500,000 to \$999,999; Project duration: 2-3 years
- 3. \$250,000 to \$499,999; Project duration: no more than 2 years

For all grant categories, there is no match requirement; administrative/indirect costs are allowable; and all agricultural commodities and production types are eligible (conventional, organic, forestry, soil/water, etc.). Fifty percent advance of funds will be provided. Periodic reporting, data collection, and participation in quartering awardee meetings will be required.

Timeline:

Applications open November 15, 2022; deadline is January 15, 2023

Awards Announced February 10, 2023. Contracts will start May 1, 2023
