#### 1. Call to Order

Chair K. Hershey called the meeting to order at 7:05 p.m.

#### 2. Approval of Minutes

# Motion by M. Harder and seconded by L. Ockman to approve the minutes of May 25, July 27, August 24, and September 28. The motion passed unanimously.

K. Hershey recognized guest S. Rebelo, who stated she is a Public Health student at UConn and Hebron resident, in attendance as part of a course requirement to observe local organizations.

#### **3.** Food Waste Diversion (CET)

M. Harder suggested discussion with A. Tierney regarding potential CET engagement, including the scope of the Committee's involvement. K. Hershey noted there is no pressing timeline, and suggested the HGC discuss further plans in a few months, perhaps after a new Board of Selectmen takes office. Tierney to discuss that matter, and perhaps other issues. There was brief discussion on communication between the Committee and town officials, as well as accounting and finance issues and practices.
