1. Call to Order

2. Approval of Minutes: February 22, 2024

3. Food Waste Diversion

K. Smyth Barry of CET and Committee members discussed strategies, information and materials preparation, and potential dates for consultant visits to Hebron waste generators, including businesses and schools. Points of contact at businesses were also discussed. School and summer schedules were noted as factors in planning visits. CET and Committee members each shared document links and will collaborate on materials. There was also discussion on funding, and keeping town officials updated on food waste diversion efforts.

4. Grant Funds (ARPA/Nickel Nip)

Three bike racks will be purchased and installed. Signage for the transfer station will also be completed. \$6,620 remains in ARPA funds allotted to the Green Committee. Remaining Nickel Nip funds were also discussed, with some discrepancies noted.

5. Church Street Project

K. Hershey noted a proposed Commons CDC mixed-income housing development, and shared communication from that group seeking a conversation with the Green Committee regarding the project, and sustainability. Meeting dates of both entities will be shared.

6. New Members

Continued recruitment of members is ongoing, and will be prioritized in the coming months.

7. Other Business

M. Harder noted Hebron Day is upcoming. L. Ockman reminded members to sign up for Swap Shack dates.
